She stated the correct rates should have been a base rate of \$51.46 and a per gallon charge of 0.010973, rather than how they were entered at base rate of \$65.75 and per gallon charge of 0.03283. She stated everyone affected would see a credit on their bill for any overcharge. There was discussion and everyone present stated they appreciated the updated information and were happy to hear credits would be issued and the rates had been corrected moving forward.

With there being nothing further, the meeting was adjourned at 6:45 p.m.


